Subject: Recent Actions Taken by the Sunshine Canyon Landfill Local Enforcement Agency Board of Directors

This is to provide you with information on certain actions taken during the August 29, 2013 meeting of the Sunshine Canyon Landfill Local Enforcement Agency Board of Directors (Board), the Board passed a motion requesting two actions regarding the Recommendations of the Interagency Task Force on Odors at the Sunshine Canyon Landfill. The Board also instructed the SCL LEA regarding a request by the Sunshine Canyon Landfill Community Advisory Committee (SCL CAC).

The Interagency Recommendations Report was discussed as Item #6 on the Board Agenda. After the report and discussion by the Board a motion was made and passed requesting that the 19 recommendations included in the report be placed in a table and a responsible agency or agencies be identified with each recommendation for investigation by that agency for further enforcement action. This table and follow up actions by each agency should be discussed at the next meeting of the Task Force.

Second, the South Coast Air Quality Management District incorporate the recommendations that are within their purview into any future revised Stipulated Order of Abatement with Republic Services at the Sunshine Canyon Landfill.

In response to the motion, Mr. Mohsen Nazemi of SCAQMD requested that the Board motion include all agencies to implement recommendations within their purview. I agreed to check with legal counsel on sending a similar letter to all other partner agencies.
