## NOTICE OF PUBLIC HEARING

The Los Angeles County Department of Regional Planning Hearing Officer (Hearing Officer) will conduct a hearing on the remanded Browning-Ferris Industries of California (BFIC) appeal of the Notice of Violation (NOV) related to the **Sunshine Canyon Landfill**. This hearing was ordered by the Los Angeles County Superior Court in Case No. BS 170149 on December 14, 2020 (Court Judgment). Both parties to the appeal should be prepared to present and discuss, among other items, the following:

- 1. The scheduling of future hearings;
- 2. Whether or not draft findings of fact should be prepared by both parties and presented to the Hearing Officer for her consideration;
- 3. How many hearings, if any, should be held for the parties to present their positions on remand;
- 4. Identification of issue(s) to be determined on remand as required by the Court Judgment in the parties' view; and
- 5. Identification of any other issued the parties believe relevant to the Court Judgment remand for the consideration of the Hearing Officer.

The Hearing Officer may make orders she deems necessary and relevant to the resolution of the Court Judgment remand and pending appeal by BFIC.


