By letter dated October 22, 2014, the County of Los Angeles, Department of Public Works (DPW) requested the submittal of a monthly activity report providing information on operational activities and occurrences at the landfill. In response to this request, the monthly activity report for the month of March 2026 is attached.

In addition to the attached report, the following information is provided:

- The installation of vertical gas wells and horizontal collectors are done in accordance with the procedures contained in the 'Construction Emissions and Odors Reduction Written Procedures' submitted to the South Coast Air Quality Management District (SCAQMD) on December 9, 2011.
- All flare shutdowns/startups are reported to SCAQMD as required and the corresponding Forms 500-N, Title V – Deviations, Emergencies and Breakdowns are submitted to SCAQMD on a monthly basis.
- During the month of March 2026, all flares operated in compliance with the site's Title V permit conditions;
- The data from the on-site weather stations is located at the SCL office and the southern berm portion of the City South portion of the landfill for March 2026.
- The LEA monthly inspection report for March 2026 was not provided to SCL by April 15, 2026. SCL will include it in April's Monthly Activity Report. SCL has included the most recent LEA monthly inspection report from February 2026. The report includes a detailed description of the site observations made by the LEA.

The compliance perimeter gas probe on the city and county sides were monitored during this inspection period. At the time of the inspection, Probe 245-B had a methane gas concentration reading of 7.0% by volume. Two independent gas monitors were concurrently used at the time of the inspection and both gas monitors received similar reading results.

The remaining perimeter probes were either non-detect for methane gas, or below 1%, by volume, except for probes: 205R-D @ 1.9%, 218-A @ 5.0%, 218-B @ 3.6%, 245-C @ 2.0% and 245-D @ 1.9%. Compliance Wells #205R, #218 and #245 continue to be monitored for changes in methane gas concentration as of the end of this observation period.

Following the initial methane exceedance in March 2024, Republic Services launched a comprehensive investigation, utilizing laboratory analytics to confirm the gas was landfill-derived. This diagnostic phase included a rigorous evaluation of historical monitoring data and land surveys to determine the interaction between the probes of Compliance Well P-245 and the facility's liner system. In response, the operator and its contractors intensified wellfield tuning efforts near the well. However, despite the periodic submission and implementation of several Gas Remediation Workplans to the SCL-LEA, these combined operational adjustments have yet to achieve consistent compliance. On January 21, 2026 the SCL-LEA issued a Compliance Schedule for Perimeter Probe 245. The deadline to comply with the schedule is July 1, 2026.

The probe remains out of compliance at the conclusion of this period, the operator will be required to implement more aggressive mitigation measures, pending approval from both the SCL-LEA and CalRecycle.

Areas of Concern

27 CCR 20820 - Drainage and Erosion Control

(a) The drainage system shall be designed and maintained to:

- (1) ensure integrity of roads, structures, and gas monitoring and control systems;
- (2) prevent safety hazards; and
- (3) prevent exposure of waste

The observation period was characterized by cool, overcast conditions with five days of rain. The on-site rain gauge recorded a total of 4.98 inches of precipitation, further taxing a drainage system already strained by the previous months' rainfall. This resulted in increased erosion along the side slopes and the exposure of waste, particularly on slopes CC3B and CC5A below the current working face. Furthermore, several instances of tracked-in waste identified in the previous inspection specifically, within cells CC3A, CC3B, and CC4 Part-3 remain unaddressed at the end of this observation period.

Moving forward, the operator is required to take immediate action to cover all exposed waste and remediate the erosion on the slopes. In accordance with the approved Wet Weather Plan, site management must conduct a comprehensive assessment of all areas to document all damage. A complete report must be provided to the SCL-LEA detailing the necessary repairs along with a schedule of anticipated completion.

27 CCR 20650 - Grading of Fill Surfaces

Covered surfaces of the disposal area shall be graded to promote lateral runoff of precipitation and to prevent ponding. Grades shall be established of sufficient slopes to account for future settlement of the fill surface.

By the end of the observation period, standing water was reduced to a few remaining ponds, primarily within the County areas. While the operator pumped the larger ponds intermittently, they have been formally instructed to remove all standing water on a regular basis. Notably, the large ponds in CC% and across the decs of CC3A and CC3B were successfully eliminated before the period concluded.

To ensure long-term compliance, all covered surfaces of the disposal area must be graded to facilitate lateral runoff. Slopes must be steep enough to prevent ponding and minimize water infiltration into the filled section.

Inspection Report Comments

This report is a compilation of the SCL-LEA staff observations for the month of 2026 February.

Active filling occurred mostly in the CC%-A area. However, during and immediately following rainy weather conditions the working face moved to the prepared wet weather deck in CC4-Part 4 C.

The spotters were directing traffic during this observation period.

The bird control measures were in place to control the birds.

The water trucks and sweepers were in use for dust control on the days that did not rain.

The portable water-atomizing cannons were in use. Misters were also in use on the perimeter fences and along the haul road for odor control.

Construction progress continued the final cell, with lining work proceeding on days when precipitation allowed. This project did not interfere with regular traffic flow. Additional spotters were stationed to oversee construction-specific truck movements when necessary and clear signage remained visible to all drivers along the active haul road as of the end of this observation period.
